The Federal Government of Somalia has received financing from the African Development Bank Group towards the cost of the **Drought Resilience and Sustainable Livelihood Programme II - Somalia Project**. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for **Gully Erosion Control: Vegetation, Fencing, Diversion Banks in three Locations** in Puntland State of Somalia.
